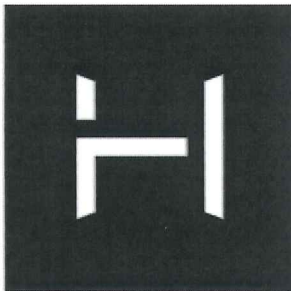

Dear Holli:

Mike Watkins and I have reviewed our notes and anticipate your transcript will run 6210 pages. At \$4.25 per page, that is an estimated total of \$26,392.50.

Because we are splitting the work, we require payment in advance in checks of equal amounts. As soon as we each receive a check for \$13,196.25, we will begin the transcript. If we have overestimated the page count, we will send reimbursement checks; if we have underestimated, we will send an invoice for the remainder. Upon receipt, we will deliver your transcript.

Under our rules, we have 60 days in which to complete the work. Upon receipt of a check from your law firm, the 60 days begin. In the event we need additional time to complete the transcript, we will request an extension from Court Administration, who will notify you if the request is granted.

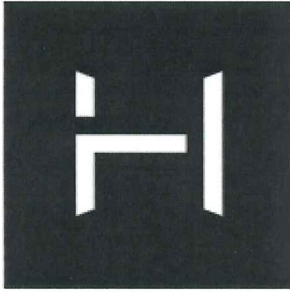
