

II - 1st Offense; Possession Of Less Than One Gram Of Meth. or Cocaine Base, 1st Offense; Trafficking In Meth. or Cocaine Base - 28 G Or More, But Less Than 100 G - 1st Offense before the Honorable Carmen T. Mullen, Presiding Judge, Fourteenth Judicial Circuit; and Terrio Jacquard Thomas appeals the Denial of his Motion for Direct Verdict on November 9, 2021 and Motion for a New Trial before the Honorable Carmen T. 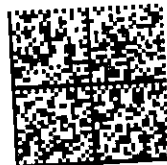

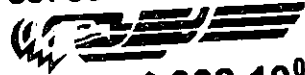
