


I request that you provide an original transcript of those proceedings (in part only, due to relevance) as follows:

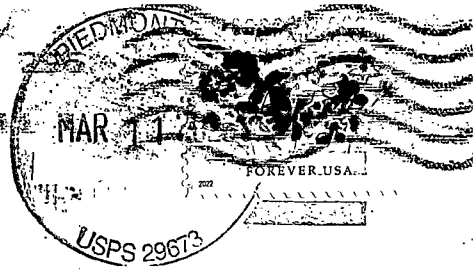
