Quinton Jarrell Kershaw appeals his guilty plea and sentence imposed by the Honorable Eugene Griffith on March 9, 2023. The Appellant pled guilty to three counts of Attempted Murder and received the following sentences: (1) fifteen years prison suspended to five years' probation; (2) five years prison; (3) ten years prison. Additionally, he pled guilty to Voluntary Manslaughter and received a sentence of thirty years prison. All sentences are to be served consecutively. He was given 1723 days credit time served.


