**NOTICE OF WITHDRAWAL AND SUBSTITUTION OF COUNSEL**

Pursuant to Rule 264 of the South Carolina Appellate Court Rules, Respondents-Appellants Erin Wingo and David Wingo (“the Wingos”) move for an order allowing Nicholas A.
