On March 31, 2023 the Appellant was found Guilty by the Jury on Incest (Indictment No. 2020-GS-46-03820) and received a sentence of ten (10) years and to run consecutive to all sentences; twelve (12) counts of Criminal Sexual Conduct with a Minor Second Degree (Indictment Nos. 2020-GS-46-03818; 2023-GS-46-01209; 2023-GS-46-01211 thru 2023-GS-46-01219 and 2023-GS-46-01471) and received a sentence of twenty (20) years on each indictment and to run concurrent with all sentences; Criminal Sexual Conduct Third Degree (Indictment No. 2020-GS-46-03819) and received a sentence of five (5) years and to run concurrent with all sentences; and Criminal Sexual Conduct Third Degree (2023-GS-46-01469) and received a sentence of five (5) years and to run consecutive to all sentences. The Appellant also received credit for time served for one thousand and thirty seven (1,037) days on all Indictments.
