

2. ON FEBRUARY 16, 2021, THE APPELLANT WAS TRANSPORTED TO MCLEOD HEALTH CENTER WHERE HE WAS FORCED ANTIPSYCHOTIC DRUG INJECTION IN HIS BUTTCKS WHILE TWO SHERIFF OFFICERS HELD HIM DOWN. [U.S. V. 5. DURING TRIAL FOR THE APPELLATE CASE NO. 2021-000990, THE APPELLANT'S COUNSEL TONYA COPELAND - LITTLE WAS INEFFECTIVE AS STATED BY APPELLANT IN TRIAL TRANSCRIPT.

7. 

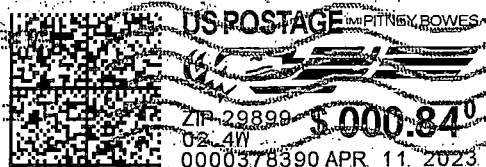
