**Subject:** Re: [External Email] Various agreements/ releases and settlements in Likins, Sulka and Alford lawsuits against the Hoaglands and Pure insurance -Damage claims against Town of Hilton Head

Kody, correct me if I am wrong, with added documentation if need be. The Likins case is over, except for the unrelated Alford frivolous lawless case where Pure paid 400k to settle the Likins case without our permission, also I and my innocent wife battling cancer was named in this lawsuit with Pure. In fact I won this frivolous Likins lawsuit, even with the deck stacked against me. The separate Alford lawsuit claiming we had no right to settle and release pure was illegal, when fact is it was totally legal and not one law says it was not legal.

We all know this likins case was also illegal and should have been tossed out of the courts and if Alford/ Likins wanted to sue me, (frivolous or not), they should have been forced to use their own money, not stolen tax money, which I discovered. Sulka talked to Likins about her also suing me, we have that email. Sulka committed perjury in her deposition, her case is also frivolous, she illegally used tax money and town resources, she illegally used tax money to join a private organization, she broke SC constitutional laws, she violated my 1st amendment rights removing me by police force from a public meeting speech I was called to make, violated my Foia, she lied, she schemed to intentionally harm the Greater Bluffton Chamber for her friend Bill Miles who runs the illegal Hilton Head Bluffton Chamber. Not one other city in SC or the entire USA has two competing Chambers that confuse the business community on which one to join.

Basically in the Sulka case, your policy says if I fail to cooperate Pure can cease representation and I would be left to defend it on my own, correct? This is what I have chosen to do, represent myself. Why would I hire a lawyer or ask Pure to represent me in another frivolous case, when it would be impossible to prove I defamed anyone, when the truth with facts were spoken. Sulka and Likins are both Corrupt and proven to be so. I am the founder of SC Watch Dog to expose corruption not commit

corruption and no one including all the lawyers can factually prove otherwise. If they can prove me wrong, I will pay a 1 million reward to do so.

You canceled our policy, we did not cancel Pure. Then in turn, I terminated any further relationship with you and the lawyer, Barrett Brewer, you hired to represent me.....

And Kody, what caused this Pure non renewal and/or cancellation of Cathy's policy based on being a high liability to Pure? Let me answer: two frivolous lawsuits caused this damage, correct? Both connected and schemed together, with one of them funded with the illicit, criminally schemed use of tax funds they claimed falsely was a bank loan. Also criminal, correct? And a 400k settlement in the Alford lawless frivolous lawsuit, correct? All done behind closed doors and in secret, and I was locked out. Sulka frivolous lawsuit filed by a ambulance chasing lawyer, with dollar symbols in his eyes. It's impossible to prove I defamed Sulka, Likins or anyone, when I can factually prove all I said was true and my full rights under the 1st Amendment free speech. Again likins and Sulka broke the law, as did lawyer Alford, Lawyer Terry Finger, Curtis Coltrane and others.

Kody we have no liability release signed for this Alford filthy lawsuit with you or Lawyer Brewer, correct? If so provide it.

I will ask you to testify with a subpoena with my lawsuit against the Town of Hilton Head, and delivered by my Florida lawyer. I am also a Florida resident. I have already hired a SC lawyer and might have two lawyers representing this case.

Both the Alford lawsuit and the subsequent cancellation of our insurance policy caused damage to both Cathy's and my perfect insurance records, all caused by the Likins lawsuit illicit public funding for private cause of action, designed to harm me and profit off the use of tax funds for private purposes, that also violated SC constitutional law. Further, the lawyer you hired, Barrett Brewer, if honest and not greedy at an innocent client's expense, should have stopped this lawsuit, versus saying it's like Mafia money, the lawsuit can legally continue. He should have never allowed this to go on, so he could collect more legal fees from Pure; and, he was also part of the schemed Alford Settlement for 400k which he claimed to know nothing about, correct?

Kody, if in fact you and all the lawyers involved claim to know nothing about this 400k Alford settlement, then please send me the names of those who did know? Certainly God was not the only one who did ?

I have asked you numerous times to settle with me on the Sulka lawsuit. We could perhaps tie in other causes of action as well. I have no interest in harming anyone, except perhaps those who harmed me and more important, my innocent wife battling cancer during all this heinous misconduct, schemed by Alford and the Hilton Head Town council. I will expect a 10 million settlement for the harm they did by allowing this frivolous illegal criminal misuse of tax funds to hurt me and worse, to profit their attorney and fellow councilperson.....and the harm they did, by this frivolous illegal criminal misuse of tax funds to hurt us, destroyed our perfect insurance record, and left me uninsured, uninsurable, unaffordable and again worse to profit. Yes they the town, will pay my and my wife's increased premiums to get the coverage we lost with Pure from this illegal criminal heinous act. And now labeled high risk for the rest of our lives.

I ask you to not violate me again by settling on the Sulka lawsuit, like you did with the Alford lawsuit. You have no legal right to represent me in any form or fashion on the Sulka case. If Ms Sulka or her lawyer what to continue this lawsuit, I represent myself and they have no legal right to continue to deal with Pure, sue pure with a lawless frivolous claims like Alford did versus me.

I give you one last chance to settle with me, sign a release with me in this Sulka case like you did in the Likins case if you wish and makes you feel better. I want Cathy's Pure policy restored, I want you to testify on my behalf on my 10million lawsuit against the Town of Hilton Head, I want you to force Barrett Brewer to sue Alford for the 400k paid back to you. I expect Likins, Alford to pay the 200k plus back to taxpayers whose money was illegally issued and used illegally criminally...and again not only a violation to SC constitutional law... but a criminal violation to state and federal banking laws, calling this tax money a bank loan, with no loan doc, no interest, no collateral and Likins paid no income tax on this free tax money to pay her legal fees.

Can you send me what you have on file that I signed, to include:

- Pures two release agreements
- Barrett Brewers release agreement
- Pures insurance termination letter in regard to Mrs Hoagland's policy, to include the reason for termination.

I have read both release agreements, and Pures release only relates to the Likins lawsuit, not Sulka, correct me if I'm wrong? Nor the Alford lawsuit challenging the validity of the release agreement.

Barrett Brewers release relates to the Likins and Sulka defamation lawsuits, both towns, but not the Alford lawsuit challenging the legality of the Pure release agreement, that 400k was used to settle the Likins lawsuit without my/my wife's knowledge, both of us whom are named in this frivolous lawless lawsuit, that the lawyers scared Pure into settling, with zero supporting law.

What gave Sean Trundy, who it seems was secretly hired by Brewer, to represent Cathy and I as we had no idea who he was and why he was recommended, and to this day has disappeared, will not return phone calls and has never sent a legal bill. Kody, does this seem strange to you?

What gave Pure, Trundy, Lee Weatherly and Brewer the right to settle with Alford for 400k without our knowledge on this unrelated lawless lawsuit? Worse, use this 400k to settle my Likins unrelated lawsuit without my knowledge.....and worse, now everyone claims (documented on the record) they knew nothing about this, including you, Brewer, Trundy, Weatherley correct? Then whose idea was it? And why was it negotiated in secret, to stab me in the back.

Tell you what Kody, we need another release with you and Barrett, the same settlement of 400k you paid crooked lawyer Alford, schemed behind my back to protect Alford and his illegal criminal act, that of using public money to sue me. And worse, disguising it as a bank loan, which violated state and federal banking laws, and against the SC constitutional law that prohibits using tax funds for a private purpose that does not benefit the public. Do you or Barrett deny this?

We need Brewer, since this 400k payoff to Alford was not covered in his release; in fact, he was a part of the scheme that destroyed my Likins

lawsuit. My plan all along, as you know, was force Alford and Likins to pay back the illicit funds they bamboozled from the Town from their own pockets, and not our insurance company to whom who we paid premiums. And worse, these actions caused severe damages to Cathy and me and also to Pure, having to pay Brewer to represent us on behalf of Pure, who was forced to defend us under their policy. Fact is, we were all violated by Brewer for not only allowing this 400k settlement scheme, but also because this was an illegally funded lawsuit which should never been allowed to proceed. It should have been tossed out of court, with a requirement that the stolen tax money be repaid. And if Likins still wanted to sue me she would have to file a new legal valid lawsuit using her own money or her lawyers could take it under a contingency. Because of these egregious acts, severe damages were caused to me and my innocent wife, who was battling breast cancer throughout.

I want more settlements, want Cathys insurance reinstated with Pure, want a lawsuit filed by Pure and Brewer against Alford to return the 400k back to Pure, and Gregg Alford, Linton and Walker to return the legal fees they received from Town of Hilton Head taxpayers, ask law enforcement AG / Fbi / Sled to act, and for both Alford and Likins to face criminal charges for their illegal criminal tax usage, as well as face charges for violations to both state and federal banking laws and Sc constitutional laws. I want Pure to sue Brewer for malpractice, or Brewer agrees to make this right, for allowing this to continue illegal tax funded lawsuit to continue, as the hoagland's suffered and continued to pad his pockets with Pure money.

Brewer made the statement to me, if the Mafia funded this lawsuit with known illegal criminally obtained money, this does not mean the lawsuit is invalid. By Brewer allowing this to continue, to profit his own pockets, versus first course of action to ask the judge to toss this case out of court by the mere fact this lawsuit was financed by a illegal criminal act, it should have never been allowed to continue even by the judge, even by Likins own admission she said if she had not used tax funds, she would not have filed the private lawsuit, if Alford and the Town did not fund this illegal criminal act on her behalf.

We lost our insurance, were labeled high risk, Cathy had to get another lesser policy for more cost/ premiums, and I could not even get a new policy if I remained her co-insured. I am now left uninsured, uninsurable and with unaffordable premiums. If Pure does not reinstate Cathys policy, I also want the Town to pay all our overcharges on our premiums to match what we lost by this criminal act

I expect Barrett and Pure to join me in a 10m lawsuit against the Town of Hilton Head to make this right, with Pure asking for their money back in the form of financial damages, to be paid back by the Town for allowing

this illegal criminal act against their client's the "Hoagland's", and Barrett Brewer will take on this case on a contingency Brewer 70% Hoaglands 30%, or Brewer will find another lawyer to represent us honestly, fairly and properly, one who believes in our case and the fact we were damaged and this lawsuit was not only illegally criminally funded by tax funds, violated SC constitutional laws, but in fact was severely punitive to the Hoaglands, who did nothing wrong. The lawsuit was in fact frivolous and we should get damages for that alone. All proven by fact we still won the case as corrupted as it all was.

Kody, you need to settle with me like you did with Alford and Barrett Brewer on all the rest. The innocent Hoaglands got severely violated and this will not be allowed to stand.

I will add more to this conversation after I hear back from you both, and what agreements you have that are different than mine, and your plan that aligns with mine to see justice served.

We can all make this a positive by joining to Sue the Town of Hilton Head, get our money back and damages, or we can fight this out in court
