

**PETITIONER'S RESPONSE TO RESPONDENT'S
THIRD MOTION FOR EXTENSION OF TIME**

Petitioner Stevens Aviation, Inc. ("Stevens") hereby response to Respondent's third motion for extension of time. While Petitioner is sympathetic to Respondent's vacation plans and ankle procedure, it does take issue with the repeated assertions that "no prejudice will be caused to either party" by these delays. In the underlying suit, Petition claims, *inter alia*, millions of dollars in contract damages and the Respondent's delays are, in fact, prejudicial (regardless of whether they might be reasonable) to Petitioner's rights to its contractual

remedies. 
