AMENDED ORDER ON

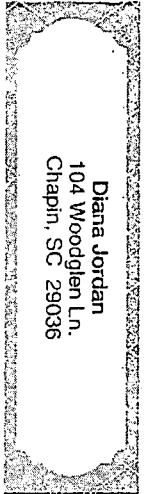

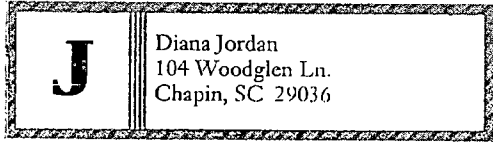
