Dear Ms. Kitchings:

The brief of appellant and designation of matter to be included in the record on appeal in the above titled case were due to be served and filed with this Court on September 30, 2022. I filed a motion to hold the case in abeyance on September 16, 2022, to obtain the transcripts of a guilty plea proceeding and an ex parte hearing dated March 16, 2022. I filed a motion to unseal the ex parte hearing on October 14, 2022. The Court ordered the ex parte hearing unsealed on November 28, 2022. Thereafter, I received a transcript dated March 10, 2022, containing the ex parte hearing. Apparently, a motion hearing, which included the ex parte hearing, occurred on May 10, 2022, and not on March 16, 2022. However, the guilty proceeding, which was held on March 16, 2022, has not been transcribed because the court reporter has not located a record of the same. Our research into the matter confirmed that a guilty plea proceeding was held on March 16, 2022. This has been verified by trial counsel and the Lexington County Clerk, and from a review of the language within the notice of appeal and sentence sheet.

At this juncture, I anticipate that a petition to reconstruct the record of the guilty plea proceeding is the next step in the case. Said petition will be filed in the very near future.
