DAY.

I AM NOW PLACED IN A STATE OF QUANTORY AS TO
WHAT MY NEXT STEP SHOULD BE SINCE THE GRIEVANCE

DEPT. IS STALLING TO GIVE ME A REPLY WITHIN THE 21
3 MO. PERIOD IS UP WHERE I WANT FILE A
COMPLAINT IN THE STATE COURT.

PLEASE DIRECT ME IN THE WAY I SHOULD HANDLE
THIS MATTER.

I WAS ALSO DENIED RELIGIOUS WORSHIP OF MY FAITH
THE 40 DAYS I WAS THERE, AND DID DISCRETIONARY
DAILY, OR EVERY WEEKLY.
