

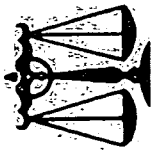
Please advise the Court of the status of the transcript within ten (10) days of the date of this letter, or your appeal will be dismissed.

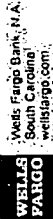

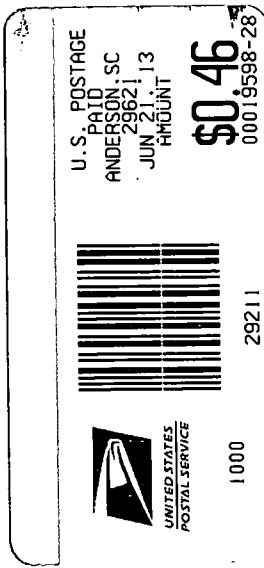
