## ORDER

---

On December 1, 2022, this court notified counsel for Appellant that the notice of appeal was not accompanied by the order on appeal or sentencing sheets, as required by Rule 203(d)(1)(B)(ii) of the South Carolina Appellate Court Rules, and warned failure to comply within ten days would result in dismissal of this appeal.

Also on December 1, 2022, this court notified counsel for Appellant that he must forward his Rule 203(d)(1)(B)(iv), SCACR, explanation for appealing to Appellant and advise Appellant he had twenty days in which to inform this court directly of any arguable basis for appeal. This court warned failure to send the letter within ten days, with a copy to this court, would result in dismissal.

This court sent letters to counsel again on January 18, 2023, and on February 17, 2023, directing counsel to cure the aforementioned deficiencies. However, counsel for Appellant has still failed to comply. Accordingly, this appeal is dismissed and the remittitur will be sent as required by Rule 221(b), SCACR.
