Motion for Reinstatement of CASE

The Appellant moves for Reinstatement of Case. Due to the unethical maneuverings of Attorney Jeffrey Scott Weathers. Attorney Weathers is a seasoned Attorney with over ten years experience in the practice of Law. I never intended him I would do the case Pro Se. maneuvering by him and Attorney Chris Conning have an uneasy connection as it pertains to the Two Transcripts of the 8/5/22, Master-In-Equity Case. A Court Reporter, MI Molly Powell recorded Transcripts of case 2022 CP 08-00478 (which I feel was a sham case) and Case 2020 CP 08-01945.

I feel that they are hiding the Transcripts especially due to Office of Disciplinary Investigations of Attorneys, Jeffrey Weathers, J. Chris Conning, Thomas Bush and Master-In-Equity Edward Von Slambrook and Judge Diane Setzer Goodstein.
