I never sat in Jail that long before and I'm 50yr

Old. I'm not Guilty of these Crimes <sup>(#49e 3)</sup>

of this and witnesses. I was never  
read my Rights and The Store  
manager said she would testify from  
Citi trends. If the Officer shows his  
video, you will see the Police Report is  
false. Ashaly Boatwright and his  
firm knew I pleade Guilty Because  
I been in there 9 months and I was  
in there for failure to Appear. I had  
Hospital Records that Mr Boatwright never
