



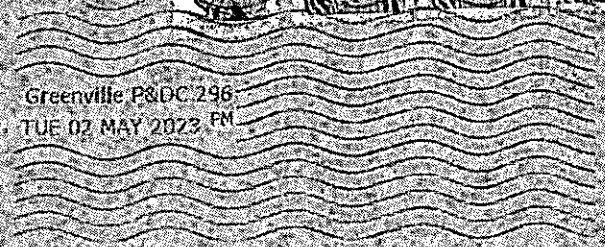
I have taken the liberty to attach the Orders involved on the Notice of Appeal.
