MOTION FOR AN EXTENSION OF TIME
TO FILE THE PETITION FOR WRIT OF CERTIORARI
AND APPENDIX

Counsel for Jason Rashaad Jones respectfully requests an extension of thirty (30) days from May 8, 2023, until June 7, 2023 in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a second request for an extension. In support of this request, counsel shows:

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.



Counsel filed the Johnson Petition for Writ of Certiorari and the Appendix in the case of Ashley L. Hammitt v. The State with this Court on April 7, 2023. Counsel filed the Initial Brief of Appellant in the case of The State v. Darrell D. Wilson with the Court of Appeals on April 5, 2023. Counsel filed the Petition for Writ of Certiorari in the case of Maurice Anthony Odom v. The State with this Court on March 27, 2023.

4. Counsel makes this request in good faith and not for purpose of delay.


