This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Initial Brief of Appellant and Designation of Matter in this case are due to be served and filed today.
2. Counsel makes this request in good faith and not for purpose of delay. Counsel filed the Petition for Writ of Certiorari to the Court of Appeals in the case of The State v.


Rashawn Vertez Carter with the Supreme Court on May 1, 2023. Counsel filed the Petition for Writ of Certiorari in the case of Roy Moore v. The State with the Supreme Court on April 28, 2023. Along with co-counsel, counsel filed the reply brief of petitioner in the death penalty case of Marion Alexander Lindsey v. The State with the Supreme Court on April 28, 2023. Counsel filed the Brief of Appellant in the case of The State v. Demetrus Lawson McClary with this Court on April 24, 2023. Counsel filed the Petition for Rehearing in the case of The State v. Mary Ann German with the Supreme Court on April 19, 2023. Counsel filed the Petition for Rehearing in The Matter of The Care and Treatment of John Shelby Wells with this Court on April 14, 2023. Along with co-counsel, counsel filed the Petition for Rehearing in the death penalty case of The State v. Timothy Ray Jones, Jr., with the Supreme Court on April 13, 2023. On March 30, 2023, Counsel testified in the death penalty PCR hearing in the case of Ricky Blackwell v. The State.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.




