I received your request for the transcript of the trial in the above case. I estimate it will be 3,100 pages, for a total cost of \$13,175. I would request a deposit of \$7,500 to begin.

Statute allows 60 days for me to complete the transcript. I will do my best to meet that deadline. However, because of the sheer size of it, it might take me a little longer. If that is the case, I will let you know as soon as I think I might need more time.

Please confirm that you received my estimate and would like me to proceed, at which time I will send you an invoice with my information for where to send the deposit.

And to Mr. Willey, I'm not comfortable providing a rough draft of something in excess of 3,000 pages. There are too many variables required in assembling a 12-day transcript. However, if there are certain parts of which you would like a rough draft (i.e., specific witness testimony), I would do my best to accommodate that. But just so you're aware of the situation, I have three other trials to transcribe before I get to yours, so producing any kind of rough draft would not happen right away. I apologize for this inconvenience to you.

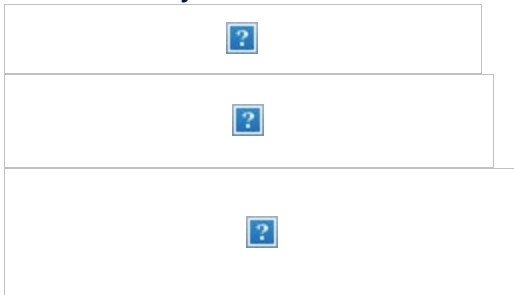
