NOTICE OF APPEAL

Anthony D. Sutherland appeals the Court Order denying his three Motions. The Honorable R. Keith Kelly issued the Court Order dated March 2, 2023. The Court Order was filed into the Court Record on March 7, 2023. This appeal is taken from that Order which denied Appellant's "Motion Application To Docket Award & Decree For Entry Onto Judgement Roll Of The Court", and "Motion That Defendant Is Barred From Prosecution" and "Motion To Dismiss" which was accompanied with Forty "Judicial Notices".

On March 17, 2023, Appellant received notice of the Court Order by usps certified mail. On March 27, 2023, Appellant physically appeared in the clerk of court's office and personally served his "Notice Of Intent To Appeal" after his initial email notice earlier that day. In April 2023, Appellant received by regular mail, those court filed copies of both proofs of service with the court filed copy "Notice of Intent To Appeal".

On April 26, 2023, Appellant sent Notice Of Appeal to the South Carolina Court of Appeals by usps certified mail. On April 28, 2023, the Court was in receipt of that Notice Of Appeal.

On May 8, 2023, Appellant received a letter dated May 4, 2023, from the South Carolina Court of Appeals. The letter noted a deficiency with the proof of service and a format deficiency with the notice of appeal. Appellant maintains those deficiencies to be directly related to General Sessions Court prejudicing his-

defense on October 27, 2022. Appellate maintains that on that day the court denied him his paid attorney's professional services and assistance of counsel to defeat the State's case and that Judge Knie did strictly forbade Appellant's Attorney, J. Zachary Farr, Esq. from proceeding in criminal court with his client anymore going forward and under the threat of facing sanctions at the Bar. Attorney Farr under those circumstances could not both please the court and fulfill his Fiduciary role to his client.

Now Appellant has put forth his sincere good faith effort to correct all deficiencies in format in this "Notice Of Appeal". Appellant is very thankful for the South Carolina Court Of Appeals Notice to him and for the allotted time given to make the corrections.
