
At the Hearing on Defendant's Motion, Roberts Vaux, Esquire, counsel for Defendant Fielden, presented the Court with several arguments challenging Plaintiff's standing to bring a foreclosure action, inadequate Notice of Default and Acceleration as provided in Paragraph Twenty-Two (22) of Defendant's Mortgage, Plaintiff's failure to strictly comply with the transfer requirements for Defendants' Note as required by Section 2.1 of Plaintiff's Pooling & Servicing Agreement (PSA), conflicting endorsements on Defendant's Note, inconsistent and conflicting allonges to the Note, the requirement that such allonges be attached to the Note and the non-negotiability of Defendant's Note.
