current vehicle in their possession,

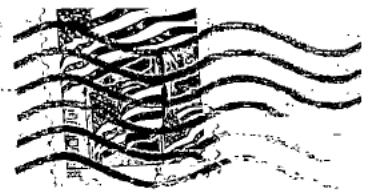
