All,

The McIntires and Seaquest have resolved their dispute, and the McIntires have released their claims against all parties as part of the agreement. Accordingly, we need to dismiss our claims in the circuit court and withdraw our portion of the appeal in the Court of Appeals. As you know, the stipulation of dismissal in the circuit court requires the signature of all parties. I attach a draft. Naturally, the subcontractors will not want to waive any argument that the case is already over to them by signing this stipulation, so I have included language stating there is no such waiver. Happy to modify it if needed.
