I noticed there was a lot of spying, watching and stalking at Schaeffler.

I told some people that I notice y'all are spying, watching and stalking they

I don't know what you are talking about but they did know. One day I

was working minding my business a guy came up to me and started screaming

saying I'm trying to take his job and make all the money. There was some people

who was treating and talking to me badly but I did not know anyone I was working

with. I was a good worker and skilled.

I am a kind, nice good person. I

loved my job I loved what I did there.

I always helped out in my department and other departments.

I started having to get off early so I can take my daughter to school. My badge always worked when I clocked in and out but

one day I clock in and was not able to clock out. I already had spoke with the manager about my situation. I only had a warning when they fired me.

I noticed after I spoke with the manager my badge stopped working. There's a steps you have to take on paper warning all the way to termination.

Taking your badge the walking you out. That's not what they did. I was fired without all the steps being taken. I

started filing for my unemployment weekly at the Department of Employment Workforce in Lancaster, SC. I did not know

for an appeal until 7/19/2022.

The lady name Bernise but I don't know her last name showed me in the portal under documents about the letter. Bernise told me to only read the part about Reason for Determination.

I did just what she told me because I thought she was trust worthy. I also thought the small print in the box was for office use only because she told me to read the Reason for Determination only.

I did not know about responding within ten calendar days, including weekends and holidays until 7/19/2022. When Ms. Bernise told me this we was in the backroom where the other computers were.

When I would come in the Department of Workforce weekly Ms. Bernise would say sometimes I know the mechanic's.

My youngest Daughter name is Journey McIlwain. The staff within the Department of Workforce knew what was going on because they heard "anecdotes". They just as guilty as Ms. Bernise. There were some people that was saying and doing towards me that should not have been said or done. I don't know their names. When I would go file for my weekly she would say sometimes now I work two jobs I work here which was at the Department of Workforce in Lancaster SC (Secret Society) but I don't make that much money here. The other job was at good will. As time in months passed I would see Ms. Bernise then all of a sudden I stopped seeing Ms. Bernise. She would also tell me before I stopped seeing her I have to catch buses to work.

They have been working against me so I would not get my unemployment. I no longer go to the Department of Workforce in Lancaster, SC (Secret Society) anymore.

I've been going to the Department of Workforce in Rock Hill, SC for a while now.

Also at the Department of Workforce in Lancaster, SC I had

been printing off papers from the documents for about 2 weeks in the front.

That 3 week I was told to go to the backroom and use the computer I had wanted to print my papers. When

I tried to print my papers they didn't print at the printer in the backroom

they printed at another printer but they didn't give

they do me. Like I said
I no longer go to the
Department of Health
in Lancaster, I go
to the one in Rock Hill, S.C.
Area of Schaeffler Group
INC. It was a toxic
place to work at and
there was a lot of jealousy
towards me. One of the
ladies at the animal shop
asked why I wasn't
working at Schaeffler
any more because I was
a member. I told her
I was fired. She said
wasn't you and a friend from
they like. The way they
didn't was not correct
it was unwanted.
