On February 10, 2017, Mr. Rutter appealed a decision of the City of Columbia Design/Development Review Commission (“City”) to the circuit court. The circuit court reversed the DDRC’s decision on May 30, 2018. On June 25, 2018, the City noticed an appeal of the circuit court order to the Court of Appeals. On June 30, 2021, the Court of Appeals reversed the circuit court. Mr. Rutter’s Petition for Writ of Certiorari was filed on September 27, 2021. On May 17, 2023, the Supreme Court denied Mr. Rutter’s Petition for a Writ of Certiorari. On May 18, 2023, this Court issued its remittitur.

Therefore, Appellant City of Columbia Design/Development Review Commission, by and through its undersigned counsel, does hereby move, pursuant to Rule 222, SCACR, for an Order
