Yes, thanks for confirmation of papers requested in pdf form from Roland. I appreciate your patience. I'm stressed and I want to be sure everything else was also in the package I mailed for Roland to William Blitch. I don't want to have accidentally left this out of his package.... So I attached a few items in pdf format that Roland gave me to mail...just to be sure. . It's been confusing and hectic, thinking the attorney quit after seeing him walk up to us in the courtroom and hand ( serve) Roland Ex-Parte papers on Feb, 14, 2023.. already signed by the judge and stamped) .. this was following 2 weeks of harrassment and threats Roalnd would be on his own... as Lir said he would quit if he did not bring more money to court that day.... (Lir lost receipts) along with other communications, documents... and Lir will not provide a statement... Lir's court papers (Ex-Parte) were a blatant lie, and Lir knew it. .. Roland feels this was thought out ahead of time, because at the very same moment he handed Roland folded papers, he also told Roland and myself he had good news...the Solicitor was going to drop all charges, to somehow minutes later.. Lir's personality changed to pressuring Roland, intimidating him and now oddly hurrying him to now just sign before the judge comes in ( Lir already had a paper prepared) admitting guilt (even tho Roland was innocent) in return for now a short probation, but now promised no charges or anything else would be filed...
