


The jurisdiction of this immediate appeal is governed by S.C. and Code Ann.s 14-3-330 (1976 & Supp. 2003).

Appellants Terron Dizzley, Gwendolyn B. Frasier, and LaQuesha Felder Appeal the orders from the S.C. Court of Appeals, (1) Order denying Emergency Motion to Relieve Counsel and Proceed Pro Se, dated May 12, 2023; Appellant Terron Dizzley received notice on May 19, 2023; (2) Order denying Appellants Gwendolyn B. Frasier and LaQuesha Felder the right to appeal and right to access the court, on behalf of the Honorable Judge Lockemy, dated May 4, 2023; (3) Order remanding case back to circuit court and granting Attorney General's request to hold Appellants' Emergency Motions For Immediate Release, Double Jeopardy, False Imprisonment, Lack of Trial Court's Jurisdiction to Impose Sentence, First and Fourteenth Amendment Rights to Familial Association in abeyance filed in the S.C. Court of Appeals, dated August 12, 2022. Appeal from August 12, 2022, order tolled by timely filed Motion for Update and Request for Conditional Order, of which Appellants objected to holding their case in abeyance, and remanding case back to circuit court, of which the S.C. Court of Appeals refused to respond. Appeal from August 12, 2022, order also governed pursuant to, subject matter jurisdiction may be raised at any time, even for first time on appeal, may not be waived, and must be taken notice of by appellate court.
