State, 345 S.C. 332, 338, 548 S.E.2d 862, 865 (2001), abrogated by Fishburne v. State, 427 S.C. 505, 832 S.E.2d 584 (2019) (upholding PCR court's finding that Petitioner was not prejudiced by appearing in prison jumpsuit for duration of his trial).
