AFFIDAVIT OF RECORD

1. Bond hearing decision 5/24/2023, In law: FRAUD upon the court.



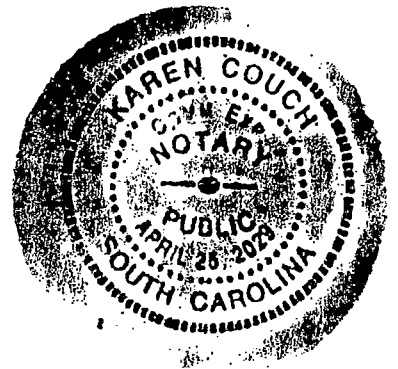

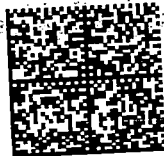
