1. Reference to: Anderson County defacto Summary Court, at Williamston, S.C., magistrate case No: 2022-CV-0410700014, by an Unconstitutional summary judgment, rule 56 a star chamber procedure in Fraud, collusion, conspiracy with: EYZC LLC & Stokely- lawyer.



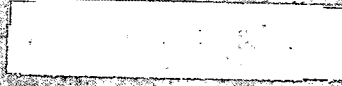
