previously granted and the order in which counsel attempts to manage his caseload, counsel hopes that no further extension requests will be required.



Counsel filed the initial brief of appellant and designation of matter in the case of State v. Maurice Prioleau in the Court of Appeals on March 22, 2023. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Sean James in the Court of Appeals on March 7, 2023.

4. On May 31, 2023, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing, by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through June 30, 2023.


5. Counsel anticipates filing this brief by or before June 12, 2023.


