## ORDER

Respondent moves to dismiss Appellant's notice of appeal, citing Appellant's failure to comply with Rule 207(a)(1), SCACR, by failing to order the transcript of the circuit court hearing from January 6, 2023, from the court reporter within ten days after service of the notice of appeal. Respondent also moves to shorten the time for further filings by the parties. We grant the motion to dismiss and dismiss the appeal.
