Counsel filed the return to petition for writ of certiorari in the case of Angelo H. Taylor v. The State with the Supreme Court on April 20, 2023. Counsel filed the petition for writ of certiorari to the Court of Appeals and accompanying appendix in the case of The State v. Jason Stoots with the Supreme Court on April 17, 2023. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Anthony Morrison v. The State with the Supreme Court on April 13, 2023. Counsel had an oral argument in the case of Mitchell Logan Hinson v. The State before the Court of Appeals on April 13, 2023. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Bobby Goode v. The State with the Supreme Court on April 6, 2023. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Jiovaani Aranza Gallegos with the Court of Appeals on April 5, 2023. Counsel filed the brief of petitioner in the case of The State v. Thomas Stephen Acker with the Supreme Court on April 4, 2023.


4. Counsel makes this request in good faith and not for purpose of delay.


