My apologies to the Court for the oversight regarding the Exhibits. We received a letter dated April 5, 2023, that referenced an attached Request for Transcript of Record (Request). 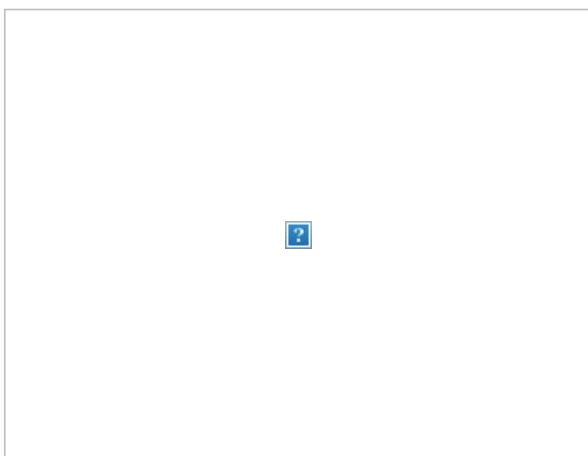
Mr. Belcher,
