Adriane Burk sent an affidavit of indigency to Dr. Faltas on April 25, 2023 and asked her to return the affidavit to our office by no later than May 17, 2023 so we could screen her for indigency. In a telephone conversation Adriane had with Dr. Faltas on May 15, 2023, Dr. Faltas told Adriane that she would be placing the affidavit in the mail to meet our deadline of May 17, 2023. However, as of today's date, our office has not received the completed affidavit from Dr. Faltas, so we have been unable to screen her for indigency.

Adriane is therefore mailing Dr. Faltas another affidavit of indigency today. She has instructed Dr. Faltas that we must have this affidavit returned to us by Monday, June 19, 2023, so that we can screen her for indigency. Please contact me if you need additional information or have any concerns.
