I, Faranda Caldwell was working at Schaeffler in Fort Mill, SC. I worked third shift from 11pm to 7am. Sometimes I would work over on first shift a few hours or the entire first shift. Once school started ~~I~~ my son Ny'Jay and my daughter Journey would be at my mom's house and my daughter Aaliyah I would take her to my sister Cindy Caldwell before going to work. I started having to get off early because I had to take my daughter Aaliyah Caldwell to school. She had to be there by 7:20 am. My daughter Aaliyah had been crying going to school and I did not know until my mom told me. I went to take my daughter to her Aunt before going to work one night but my sister her boyfriend and my nephew did not come to the door. I Faranda Caldwell and my daughter Aaliyah knocked knocked and knocked rung the door bell several times no one came to the door. So I did what I had to do and start taking my daughter Aaliyah to

School. I was able to take my son Ny'Jay and my daughter to school. Before this occurred I already had asked my Aunt Florie Dickerson which is my dad's sister, my uncle Charles Dickerson's wife, which is my mom's brother. My Aunt Florie Dickerson told me I can not get anyone to keep my kids which was before school started. I spoke with my manager about my situation. One day I clocked in and was not able to clock out. I only had a warning when I got fired. I started filing for my unemployment weekly at the Department of Workforce in Lancaster, SC. I did not know I had to respond by 5/9/2022 for an appeal until 7/19/2022. The lady's name is Bernise but I don't know her last name. She showed me in the portal under documents about the letter. Bernise told me to only read the part about the "Reason for Determination". I did just what she told me because I thought she was trustworthy. I thought

When Mrs. Bernise told me that the small print in the box was for office use only so I did not read the small print in the box. I did not know about responding within ten calendar days, including weekends and holidays until 7/19/2022. When Mrs. Bernise told me this we was in the backroom where the other computers were at the Department of Workforce in Lancaster, SC. When I would come in the Department of Workforce weekly Mrs. Bernise would say sometimes I know the McIlwain's. The staff within the Department of Workforce knew what was going on because they heard and saw what was going on. There was some staff members at the Department of Workforce in Lancaster, SC saying and doing things towards me that should not have been said and done. I did not know anyone in the Agency the Department of Workforce in Lancaster. When I would go file for my weekly two job searches Mrs. Bernise

Sometimes said Now I work two jobs I work here which was at the Department of Workforce in Lancaster SC (Secret Society) but I don't make that much money here.

The other job was good will. As time and months passed I still saw Ms. Bernise more.

Months passed I still saw Mrs. Bernise then all of a sudden I stopped seeing Ms. Bernise. I stopped seeing her because I was speaking the truth about what's going on.

I also spoke with the manager at the Department of Workforce about another lady what was said towards me and nothing was done. I don't know her name or who she is. The manager also knew what was going on. For two weeks I was printing off copies from the documents in the front where every staff was able to see. The third week I was told to go to the backroom where the other computers was and printer. I tried to print some copies at the

the computer but the copies did not print at the printer in the backroom; My copies had printed at the printer in the back where staff is at because I was able to see that's where my copies went to. The staff did not give me my copies that was printed at that print in the back where they are at. I Faranda Caldwell have been harassed, bullied and stalked at the facility Department of Workforce in Lancaster, SC. (Secret Society). Intentionally attacking. They was intentionally trying keep me from getting my unemployment. My mail has been being played with at the post office and postal service at the address where I use to stay 1430 Mcilwain Rd. I was checking out at the post office one day and someone came from the back and steal the name Mcilwain so I can see it then took it and walked off. I No longer go to the Department of workforce in Lancaster, SC (secret society) I now go to the Department of Workforce in rock hill, SC.

I've been doing this for a while now. There is two ladies there but I don't know their last name. One week the lady ask is my youngest daughter name harmony. She knows what my daughter name is. Harmony is my cousin Jacqueline white daughter. The next week the other lady I don't know her name said to me right before I went out the door she was sitting at the desk at the front door she said family is important. I am being harassed, bully, stalked. I know family is important, my family needs to know family is important. They think they know my family and they don't. Since I've been going to the Department of workforce in Rock Hill, SC I had to change my email and passwords.
