I have been placed in Manning's Restrictive Housing Unit (RHU) Lockup for something in which I am not guilty of nor had anything to do with. I was placed in the RHU on February 28, 2023. I was presented a form initial placement for an approximately 8 hours after my being placed in an RHU cell (Cell 22A). This form, although it stated that I was placed in RHU "to preserve the integrity of an investigation" it did not inform me of any more information and did not inform me of the projected length of my placement. This form also stated that I had been consulted by Manning Medical and Mental Health personnel and/or in the alternative that I had been questioned by staff with regard to my medical and mental health conditions prior to being placed in the cell. As I had not been consulted by anyone, I declined to sign this document.

As of today, March 22, 2023, I have not been afforded the opportunity to be heard. I have not, at any time, been provided the opportunity to participate in any hearing or review which would inform me and allow discussion and hear and/or review the justification for my placement and continued placement in the RHU. I pose no danger, risk, security threat, nor any similar caution or risks. Thus my placement in RHU is unquestionably unreasonable as myself, my living quarters, and my work area, and property has all been searched thoroughly and no contraband nor cell phone was found. I have been wrongly placed and continuously held in the RHU without proper and sufficient Due Process. I have not been provided any documents.

ACTION REQUESTED: That I be provided a hearing and review as to the justification for my placement and continued placement in the RHU. I would like to be heard before a fair and impartial panel without conflict of interested parties. I would like to be provided any and all documents which concern my placement in RHU.

I have been placed in Manning's Restrictive Housing Unit (RHU) Lockup for something in which I am not guilty of nor had anything to do with. I was placed in RHU on February 28, 2023. Since March 3, 2023, I have been both, informing Manning's administrative staff that I have legal actions pending and that I have pending legal deadlines to meet. I have continuously asked that I be allowed to access my legal files which consists of (3) green duffel bags which were separated from me ~~and~~ as I was placed in the RHU. I have been denied opportunity to access my legal files and also to be provided a desk/clipboard for writing. (I did ask that metal clip be removed from clipboard). I originally submitted an SCDC Form 19-11 "Request to Staff member" (paper request form) and it was submitted to Major Burnell and Warden Duncan for approval of access to my legal files. However, I never received an answered SCDC Form 19-11. As I have been placed in the RHU and am being held as Short Term placement (ST). However, I have not been informed of how long I am going to be held. As I am in (ST) (Section 11.2 of SCDC Policy OP. 22.38 "Restrictive Housing Unit"), inform that I am entitled to Level 2 privileges, activities, and authorized property. (Section 11.2.5). As part of the Level 2 privileges, I am entitled to keep in my possession/cell, a box which is sized 15X12X10 (Legal Box) (Section Page 39 of the policy) and am entitled to exchange legal files from other legal boxes belonging to me as needed (Section 15.12). Manning's administrative staff have unconstitutionally and unlawfully denied me access to my legal files and have caused me to miss pertinent filing deadlines and have prevented me from meaningful access to the courts.

ACTION REQUESTED: That I be allowed access to my legal files, compare a legal box for keeping in my cell, provided a desk/clipboard, that my (3) Green duffel bags be video recorded during any and all interaction with the bags, that the seals be clearly captured before and after accessing, that all contents be captured on camera until resealed.

I have been retaliated against by (1) not being provided any hearing nor review (2) not being allowed to speak with any investigator who is investigating (3) being placed in the cell where a prisoner was recently hung (4) not being provided any access to any of my legal files, nor a desk/clipboard for writing (5) Placed where bright light is on 24 hours per day (6) not provided the contact information of the News media I was accused of calling (7) caused to miss legal deadlines and to proceed in my legal actions meaningfully by submitting filings necessary to prosecute my cases in a meaningful manner (8) not receiving answered RISM 19-11 Forms (9) not being provided any documents as to my placement and continued placement in the RHU (10) Being removed from my Job (11) Being removed from leadership position in the Christian community and Chapel (12) Being removed from programming and opportunities (13) not allowed to earn my On-The-Job work training hours and experience (14) have caused my mental health to decline (15) placed in contamination cell. The ~~retaliation~~ retaliation is a result of me having the contact information to the news press in my possession. 

As a result of my being in possession of a WIS News media contact name and contact information - this contact name and contact information was taken from me, my work area was searched, my living quarters was search, all of my property was thoroughly searched, and I was then placed in Manning Correctional Institution's (Manning) Restrictive Housing Unit (RHU), based solely on this. I asked, among other things, that I would be released from the RHU and that I be returned to my positions. I asked also that the WIS News contact name and contact information be given back to me. In turn, I was refused this contact information and rather caused to remain in the RHU for approximately 29 days and ultimately shipped without still being provided the contact info. I have been stripped of the contact information. There is no SCDC Policy nor SC Code of Law which deems it against SCDC Policy or SC Laws that I be in possession of such contact information. Manning's Administration has effectively gagged me, silenced me.

ACTION REQUESTED: That I be provided the contact name and contact information that was taken from me. That I be rewarded \$250,000 per each person who participated in violating me and my rights. That my First Amendment Constitutional rights be respected.

I have reviewed your concern. In it you stated that as a result of your being in possession of a WIS News Media contact name and information the information was taken from you. You continue by saying that your work area was searched along with your cell and your belongings then you were transferred to Manning Correctional Institution and placed in RHU. You are requesting that you be removed from RHU and returned to your positions. In addition, you ask that you be given the WIS News contact name and information back. Lastly, you are requesting \$250,000 per person who participated in violating your rights. Pursuant to SCDC Policy OP-22.35, Contraband Control, "Contraband Control Officers will maintain all contraband in strict accordance with Agency policy, procedures, and laws." Items considered to be contraband: "Any items which was not issued to the inmate officially. Any items which cannot be purchased in the institutional canteen. Any item which has not been authorized by the Warden and/or Agency policy; Credit Cards, negotiable instruments, and identification documents other than those issued by SCDC facilities." You have not shown that SCDC Staff have failed to perform their job duties properly. You are advised to follow SCDC rules, policies, and procedures.

Therefore, your grievance is denied.



*Note: This grievance is an attempt to cure the deficiency of Grievance No. MRWEC SM 0063-23, which I submitted while housed at Manning and was received at Grievance office on March 27, 2023. The grievance was returned to me on April 25, 2023, processed and determined that I have attempted to grieve multiple issues in one grievance. Albeit I disagree with the determination this is my attempt to cure and I intend also to submit a SCDC Form 19-11 to the Chief Branch Grievance Coordinator.

I was placed in Manning's R4U on February 22, 2023. Beginning on March 3, 2023, I began to inform Manning staff and its administrative staff that I had pending legal actions, deadlines to meet which were closely approaching, and that I also needed to submit ~~into~~ supportive filings and court orders in my cases - and thus needed access to my legal files which staff had packed within (2) green duffel bags upon placing me in the R4U. I was specific and did emphasize that the files were located within the (2) green duffel bags. I did submit a written request to staff form 19-11 to Warden Burnett and Warden Dunaway as well. I sought that I would be provided access to my legal files and that I would be allowed to compose a legal box from amongst the total files to be placed and kept in my cell to enable me to proceed in my legal actions, to make timely filings, and submit supportive litigation. I was denied this opportunity, in direct contradiction to SCDC Policy OP 22.38, section 39 and therefore denied access to the court by way of Manning staff's hinderance and dilatory actions.

ACTION REQUESTED:
I would like to be provided all (3) of the green duffel bags and have access to these for proceeding in my legal actions and my rehabilitative and reentry programming. The seals should not be broken on these bags. All staff who have participated to pay me \$250,000 each.



If this would have been a chargeable offense, which it is not, it would have been classified as a minor offense and not had any justification for my RTHU placement. My placement in RTHU was retaliation.

Note this grievance relates back to my retaliation grievance filed at Manning and is responsive to the Warden's determination or Grievance Coordinator's determination that too many issues were raised on my grievance which sought to address and raise issue of retaliation.



Note: Albert I write to inmates "I speak and bring this claim on behalf of myself and myself only. This limitation is totally in contradiction to SCDC Policy PS 10.08, which governs "Inmate Correspondence Privileges" which states that I, albeit indigent, would not be limited in the amount of legal mail I am to send out. This limitation causes me litigation because it has hindered my efforts to pursue my non-frivolous legal claims. Department of Correction officials have recognized [Signature] MAY 7, 2023 the inequity in such limitations and have elected [Signature] Grievant Signature Date to retract such policies/limitations. 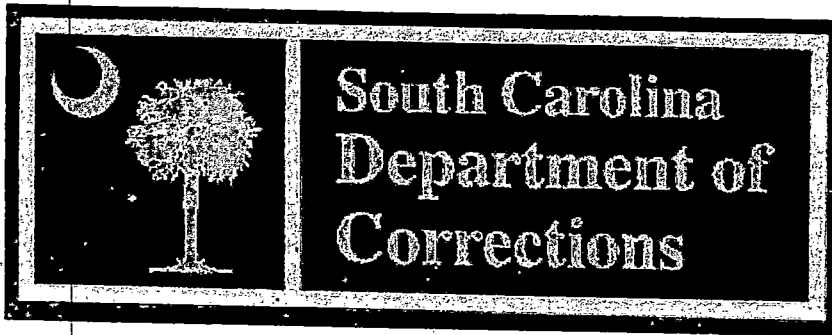


