SCACR



Comes now the undersigned attorney, William N. Epps III, hereby moves for an extension of time in which to order the transcripts to allow Appellant Defense from the South Carolina Commission on Indigent Defense to screen the Appellant. The undersigned, previously did request the transcript on April 17, 2023 of the trial of the Appellant’s case and the transcript of the hearing on Appellant’s new trial motion on May 22, 2023. However, the request for transcript on May 22, 2023 references the trial proceedings and not the motion hearing on May 15, 2023. This was an inadvertent scrivener’s error on part of the undersigned.


