We are in receipt of your letter dated June 13, 2023, requesting that we advise the Court of the status of the transcript within ten (10) days of the date of the letter. Please allow this letter to serve as Appellant's update in response to the June 13, 2023 letter.

On April 7, 2023, Appellant filed the Notice of Appeal and served the same on counsel for Respondent. On April 7, 2023, our office requested the January 3, 2023 hearing transcript. On April 27, 2023, our office received a response requesting that we pay a deposit before the transcript could be transcribed. Our office forwarded the deposit momentarily via U.S. mail. On May 1, 2023, our office received a response stating the deposit had been received and the transcript would be completed by June 20, 2023. 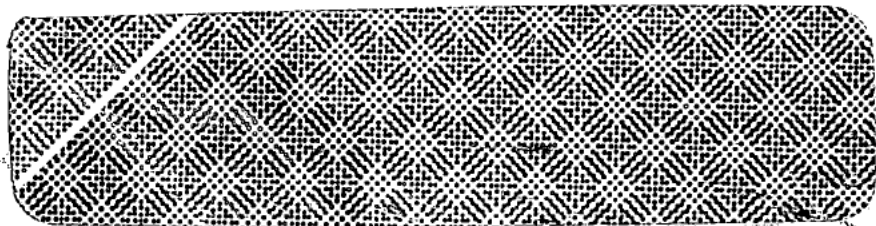
