Dear Ms. Thompson:

This letter is for the Administrator, I am not sure if that is yourself or Mrs. Shealy. I requesting an intervention from the Trustee. The Executor and those that he represents have not been addressing the medical needs of the Beneficiary, ALICIA MONIQUE RUFFIN. Most recently, the Beneficiary was in touch with Optum RX and they were able to get in contact with Liberty Mutual and a new Pharmacy Card was sent to the Beneficiary. Upon attempting to get prescriptions filled, the pharmacist informs the Beneficiary that that she must get in contact with the Insurance Adjuster. On Friday, messages was sent to the Marie Warner-Smith, Insurance Adjuster, Honna Williams, Supervisor and South Lewis II, Exexcutor. No one has made an attempt to reach the Pharmacy or the Beneficiary.

This is causing physical harm to the Beneficiary. Liberty Mutual was told to use this card for future prescriptions. But with medical card not working and the Executor and his Representative have been out of reach. This has effected the health of the Beneficiary and is causing further injury to the Beneficiary. The Beneficiary is seeking the help of the Trustee to seek relief.
