**MOTION FOR EXTENSION OF TIME
AS TO RESPONDENTS’
RETURN TO THE PETITION FOR WRIT OF CERTIORARI**

Pursuant to South Carolina Appellate Court Rules, Respondents Centex Real Estate Company, LLC and Centex Homes, a Nevada General Partnership (collectively, “Respondents”)

by and through counsel, respectfully move for an Order extending the time for Respondents to serve and file their Return to the Petition for Writ of Certiorari.

Petitioner filed her Petition for Writ of Certiorari on June 15, 2023. Therefore, Respondents' Return to the Petition for Writ of Certiorari is due to be filed on July 17, 2023.
