Counsel filed the Anders brief of appellant, record on appeal, and designation of matter in the case of The State v. Mack Adams Gaines with the Court of Appeals on May 2, 2023. Counsel filed the amended petition for writ of certiorari to the Court of Appeals in the case of Adonis Williams v. The State with the Supreme Court on May 1, 2023. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Wendy Green with the Court of Appeals on May 1, 2023.




