

Submission of this AFFIDAVIT OF INDIGENCY is solely to withdraw from South Carolina's ("SC") supreme court ("S Ct") any false pretext(s) to dismiss my case(s). This submission is NOT a request or consent by me to be represented by any attorney of SC Appellate Defense ("SCAD") which has conflicts of interest. This AFFIDAVIT OF INDIGENCY is submitted after my phone conversation on 13 July 2023 with SCAD's Adriane Burk, who authorized me to "do to the affidavit what [I] need to do" after I re-explained to her that I would not accept any lien provision, which provisions from the form previously sent to me have been deleted. I also modified the language about disposal of assets to make sense. ALL other questions in the form affidavit have otherwise been truthfully answered in good faith and hope that SCAD would do the right things and acknowledge the conflicts of interest and defend my basic human right to speak for myself.

I affirm that the account by me delivered into South Carolina's Commission on Indigent Defense ("SCCOID") does contain a true and full account of all my real and personal estate, debts, credits and effects whatsoever without exception, which I, or any person in trust for me, have or at the time of my possession had, or am, or was, in respect, entitled to, in possession, remainder or reversion and that I have not at any time since **the charges underlying the PCR case(s) now under appeal** were made against me disposed of any assets for the purpose of concealing them. Obviously, since my two false arrests in 2009, I had to spend all savings I ever had.

Under penalty of perjury, I certify that the information given by me on this affidavit is true and correct, and I understand that I will be subject to civil and/or criminal penalties if I knowingly furnish false information.

I am financially unable to employ counsel **but unwilling to be represented by counsel even if I were financially able to employ one or several.**

And further affiant saith not on this 17th day of July 2023. 

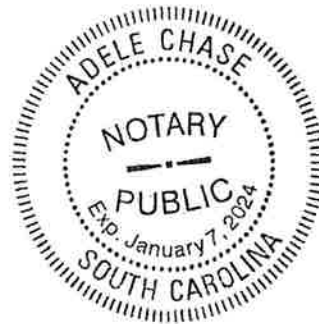
