gentleman named Joe. He had gave her his number and talked with her about coming to his church. Tammy seemed to always struggle to try and be a follower of God. I really applaud her for that, and I wanted to encourage her relationship with God as much as possible. She had called Joe, told him everything, and planned to attend the church the next morning. She wanted me to come, and Britly wanted Henry to come. So, the four of us went. It was "different" from the church we are used to, but the folks were super warm and loving. Right when we got there, the leaders of the church asked Tammy and Britly to the office. I assume they prayed with them, and who knows, may have even gave them some money? Not really sure, I never asked. That was that, we did not have plans to return to the church, it just was not our style of worship, but Tammy made the remark that it made her feel alittle better and gave her some peace. Once back at the house, the kids played, we ate some roast Rodeny had cooked and they went home. I cannot remember day by day, but I'm doing my best to fill you in since your arrest. Everthing kind of stayed the same from day to day~they would come over, ride horses, and we'd eat dinner together alot. The kids would spend the night together, sometimes mine would stay at their house, and sometimes yours would stay here.

The day this happened, Tammy immediately "set Britly free". She let her stay the night over here many times. She let Britly ride with me to pick up Henry from football practice on day. His coach was keeping them late, so I called Tammy to let her know we would be delayed. She told me, "Don't call me to tell me stuff like that. If she needs to know where Britly is, she knows my phone number and she will call "ME". She made it very clear Britly was free to do whatever she wanted to do.

During all of this, Tammy had the idea and requested to put a mobile home on our property and live here. It sounded ideal. Of course ALL the kids loved the idea. I however, was not sure if Rodney and I were ready to "adopt 5 more kids", and I basically would be "sharing" my husband, not sexually, but you understand what I mean. Rodney would be the "Father Figure" to all these kids, and Tammy would know no other role than "mother and wife". ~~But, I put my selfish feelings aside and prayed for God to~~ lead us in the direction He had planned for us. The Lord has blessed us "SO" much, I was not about to turn them away because of "not knowing" if we could handle it all. I knew it would not be easy and it would be a HUGE adjustment for our family, but Rodney and I both decided we would be here for them and help in ANY way we could. We had been letting Tammy drive our van pretty regularly. She would keep it overnight most days. We none felt the kids were safe in y'all's van without seatbelts. I would drive Rodney's truck to pick Henry up from football most days. Tammy stayed busy, it seemed like most days she "HAD" to do something. She "HAD" to met people about selling the cats, she "HAD" to return the gun safe, she "HAD" to take Britly to the doctors/investigators, ect. But alot of her had to dos~were just alot of want to dos inbetween. Rodney and I noticed how careless she was with her money. For example, she took the kids to Sandhill one day, they bought X man new boots and they purchased some various other items, and then went out to eat. There is absolutley nothing wrong with those things, and at first I thought it was good that they were getting out and having a little free time and fun together, "they needed it". But it just seemed to become a trend. Each day Tammy HAD something she HAD to

could be with her boy Mark. What woman going through this attaches herself to another man in as little as three days? We left it at that, but she could tell we did not approve of what they were doing, but she insisted it was innocent. She said, "I NEED him". She said, "Rodney and Mike are busy working. They cannot give me the help I need to sell this stuff and get money". Rodney warned her that Mark couldn't be trusted and that he'd wind up ripping her off while selling all your stuff. But she didn't pay him no attention either.

A few days later, she took Britly to get an exam. She called and said Britly had had three miscarriages. How they know that is beyond me. She said Britly remembered the feeling each time it happened. I think Tammy has filled her head with imaginary junk to make her think this?? So now, on top of being raped for a year by her dad, Britly has to endure the torture of thinking she has miscarried three babies with her father? How can she deal with that? Then the next day Tammy calls me freaking out, about to take Britly to another doctor to get a pregnancy test done. She's paranoid that Britly could be pregnant again. They said you did not use any protection. So she supposedly takes Britly and they would not do a blood test (which would have cleared things right up)~why, I don't know. So this gives Tammy something else to worry and tell everyone about for the next few days. It was just drama on top of drama ALL THE TIME! I was getting very concerned of just how much my kids were getting exposed to all of this. None of this is on ANY of these kids level~ shouldn't even have been on Britly's.

Then, I'm not sure when, but shortly after that, all the girls, Tammy, Britly, Breana, and Emma had to go to Florence to talk to an investigator. Tammy called me a couple of times freaking during the breaks that day. She feared they were going to send DSS to take her kids if they could prove she knew anything was going on before Britly reported it to her. Tammy wanted me to lie for her if they called, telling them she worked for me like a nanny or something and that I paid her a few hundred bucks a week. I told her whatever, and that she's worrying unnecessarily over all this. I told her she was a good mom, and that we spent alot of time with them over the past few months before you were arrested, and that we considered ourselves to be good parents too. And my point was, that if we couldn't see what was going on, it was no surprise that she didn't see it either. I assured her, they won't take her kids. I reminded her of her plan to get a home, car, and a job to support her family. She seemed to calm down. But the very next day, or it could have been the same day, she calls me again~freaking. She asked if Oliver and Bella could come stay with us while she took her kids to Charleston to sign them over to her sister's custody. She was in a panic that DSS were on the way to take them. To me, all this was completely coming from left field because it just didn't make since. "How can they take your children", I asked? She told me her sister is a foster parent. The lady who is her sister's caseworker was informed about Tammy's situation (I guess by her sister?), and this lady suggested Tammy sign her kids over to her sister until she has proof of a job, a home, and transportation for them. Tammy was freaking out, because she said if the government gets them, they'll be made to go to school and get immunization shots. So to her, it was the right thing to do. Now keep in mind, all the kids are in the car during this whole conversation, hearing this, how are they processing this? I'm telling you, she's done nothing to

never seemed to be a priority to her. So for my families sake it was time for us to pull out of all this drama. I told her "I" made the decision and Rodney agrees with me. I explained based on the supposed FACTS she shared with me about how dangerous you were if you were to get out of jail, and the fact that you had it out for Henry, we needed to stop ALL CONTACT with her and her family immediately. I have never spoke another word to her after I talked with her on our front porch that day. So, back to what happened that day: shortly after Britly pulled up, along comes Tammy and Mark in Mark's truck. They were fixing to head to Sandhill to take care of their "business". Mark and Britly stayed outside while Tammy came in and I lead her to the front porch for us to talk. I explained my fears to her and explained why we had to stay away from them for now. I told her I hated it had to be this way. I didn't go into much that the whole reason we were pulling out was because of her behavior. If she were not running around with Mark, tampering with the investigation and making it to where you could possibly get out of jail, we would probably still be helping her today. And if she didn't just give up her children for some reason that made no since to us, we might still be helping them. But things were getting pretty fishy and nothing was adding up. So I pulled out, only telling her it was because I was afraid for my family. I don't think she even has/had a clue that SHE was the main reason we were pulling out of our friendship, and her stupid decisions and behavior. Why should I risk my families saftey so she could run around acting like I DONT KNOW WHAT???? But, here's the kicker James. As you know, our blue van has seen it's better days. It still runs fine, just a good bit of cosmetic work needed to be done on it. It just so happens, that very day all this happened, Rodney texted me a picture of my new car he bought me. Rodney and I talked and decided to give our old van to Tammy. We felt good knowing that even though we HAD to leave them alone, at least we could provide her with one of the three major goals she needed to reach in order to keep her children from being taken. So, before she got ready to walk off the porch, I handed her the keys and told her we wanted her to have the van. She said no at first, saying she had plans to buy one next week, she didn't need ours. I finally convinced her to say yes, by telling her to take this one to at least get around in until she gets hers and when she does get hers, she can give this one to Britly and they'd have two vehicles which would come in handy if they were both trying to work a job and take care of the kids. We also discussed whether or not she wanted us to keep Breana's horse a few months to see if this whole thing blows over (because we put it to her in a way to say that we were taking a break from them until this while mess is over, or at least until we know what your sentence will be)~ so I told her we could keep the horse so Breana would have it when things smoothed out. But she said, "No, I'll just call they lady to come get it, because it will just break Breanna'a heart not to be able to come see and ride it. Then, Tammy steps off the porch, I could see she was upset, and I was too. So, I go into the house, watch Britly drive away in your white van, watch Mark's truck drive away, but never saw our blue van drive out. I walked out the back door where it was parked, only to find Tammy had left the keys I gave her on the steps.

Later that night she was sure to fill Rodney's earfull either by texting or on FB messaging. She told him, that HE had hurt her family more than YOU did! She said for us to, "KEEP OUR PEACE OFFERING" (meaning the van). Rodney was firm but loving letting her know we care about them very much and we were sorry it had to be this way. She all but tried to make him feel responsible for this mess?!?!? Never

how crazy these past few weeks have been watching all this play out. We're SO relieved to be done with them. We miss the kids, none of them deserve none of this. The drama was just too much. Those poor kids are in for some kind of future, that's for sure. Although you all are gone out of our lives, we still have alot of memories of you guys. Good ones too. In the midst of all the crazy stuff happening, Tammy gave Sarah Jo and Jesse each one of the kittens. I've never had cats before, buy we all have fell in love with them. They stay indoors and they indoor dogs have adjusted well. Punkin, the little white poodle got hit by a car we think. We found her in the middle of the dirt road one day injured. It has been about two weeks now, and she's just starting to put some weight on her back legs. We don't know if they were broke, or she broke her hip. But she is miraciously recovering pretty quickly. I didn't think she'd ever walk again. John Ross was working on building her a doggy cart with back wheels for her to get around with.

We think of you each time we look out at the shelter you built, each time we look at the stalls you built. We think of Brearia each time we look at the signs she painted us. We refer to Colin, Emma, and Xman over and over again. All in all, my kids have adjusted well. We've become good friends with Mike and Tina and their girls. Jake and Mary are in kindergarten class together, and Jesse, Grace, and Olivia are at the same school too. Sarah Jo and Joanna are in the same school at North Central Middle, and they have art class together. They have all been spending alot of time together hanging out. Henry LOVES school~ NEVER has those words came out of his mouth before. He has had two home games so far. First one they won like 30/0, second one they lost like 0/40. He has another game this Thursday. I was sure to share with him what you said in your letters and he knows now you're not the monster Tammy tried to paint you to be. Rodney is good. He stays busy working and enjoying his weekends off working around here, going out on the boat, and hanging with friends. His latest toy he got last weekend. He bought a PA system for his mancave. Now he can hear his music out at the Goat's cage. It has a microphone and Rodney and Tina are our entertainment when they get tore back. They have not let me nor Mike have a turn on the microphone yet, ???~it's probably best that way~lol! Yes, we have Chevy, and we found her a mate, I think the kids named him boots. Boots was someone's HOUSE GOAT?? He is dehorned. Chevy likes to go up behind him and give him a poke, just so he remembers who was here first! HA! That poor goat has a big life change ahead. I dump them some leftovers if I have something I know they like every now and again. We now have about 25 chickens laying around 1/2 dozen eggs a day, and three roosters. Rodney brought home some bitties the others day. About twenty five of them. He said they are eating chickens, where as our other ones are hens. We have just the three horses now, the two brown and Sarah Jo's. They ride like a few times a week now. Since school has started everything is super busy. John Ross is homeschooling with me this year. He went the first day and decided it wasnt for him. Too much change at one time, he dont deal good with that. I'm very glad to have him home with me though. I didn't like being here alone when school started. He feeds the horse and chickens and does little odd jobs during the day when he's not doing his school work. He plans to go back to school next year. He will be at the High School with Henry.
