I wanted to be sure to remind you in my already submitted appeal and motion records, and attached again in this email, atty Lir Derieg, served me papers dated and signed and stamped by the judge on Feb. 14, 2023 to be relieved as my counsel. He never filed any sort of withdrawal of his motion that I was made aware of. He hand delivered this ex parte motion to me when he walked in the courtroom. As I stated in his motion he had the judge sign, the things he said were not true..as he knows he was paid thousands for this case...other info is also incorrect...I was not arrested on that date...I was transferred after being picked up for traffic violation...some 8 months after the alleged accusation in this case...

Lir appeared to be high or intoxicated this day in court... he'd been drinking heavily for months and arrested for such 2 or 3 times....

Lir never even once showed up in court with me....he never represented any of my evidence or talked to any of my witnesses... He only did messenger and maybe a couple of phone calls....he usually turned his phone off.

I arrived in court early with an already prepared statement in hand to ask the judge to allow me to fire Lir and give me time to find a reputable atty, who would actually represent me, present my evidence

The only reason I didn't read it to the judge is that Lir put that signed and stamped motion to not represent me. In my hand....Lir had harassed and threatened me for 2 weeks about money and he stated he had lost our communications.. but there was nothing scheduled on my case this day....I attached a text I found where he said there would be a hearing on his motion to quit as my atty.... Aand to me just a roll call....

Lir then told me and a friend...good news Roland.... the solicitor was dropping all chargeswe asked if he was sure and he said yes..he asked me to get one document to him from Enterprise.. within the next day or so (he already had it..but he said he lost papers, communications, and receipts)..he could not remember things he said...

Lir obviously has and had some sort of mental or addiction or other issues going on, (he looked into space with a blank stare and after threatening me all week...he served me the attached papers and and limped to go sit alone on the opposite side of the courtroom from me and the solicitor. Talking to no one... his foot was bandaged. he acted strangely and then just moments before the judge came in..motioned me to come to him..and now out of nowhere told me to trust him, just plead guilty and I'd be guaranteed nothing more but 12 months probation..but everything would be over...I'd have my life back... I didn't feel right saying guilty to something I was not guilty of at all and putting this on my record....but Lir said to trust him..it would be fine...I was totally confused, pressured and intimidated..when I got a ridiculous sentence from judge..I said Lir that's not what you just promised me..he refused to let me talk...he purposely made me took bad to judge.

This was so far from any code of ethics for any attorney..... How did he do this anyway..when

he just served these ex parte papers signed by him and the judge. I am now scheduled for court sometime in August because they have now have me paying some outrageous amount that not even a rich person could do..I am trying to do right..be a good man...but.I could lose 10 years of my life....despite my being completely innocent.. even in court they said just pay what I could... Even the court office people said they never saw anything. this...and we're praying for me....the pink paper I sent you from court. Even tho it is wrong. I am innocent..just got no fair representation...but even that has no crazy amount like that..
