

MOTION FOR EXTENSION OF TIME TO FILE AND SERVE THE INITIAL

INCLUDED IN THE RECORD ON APPEAL

Now comes the Appellants, pursuant to Rule 263(b), and respectfully request a twenty-one (21) day extension of time to file and serve their Initial Brief and Designation of Matter to Be Included in the Record on Appeal. 
