MOTION FOR AN EXTENSION OF TIME TO
SERVE AND FILE THE PETITION FOR WRIT OF CERTIORARI
AND APPENDIX

Counsel for Charles Adams respectfully requests an extension of thirty (30) days in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a second request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.
2. Counsel for Charles Adams respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the number of

extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.



On July 19, 2023, counsel filed the petition for rehearing in The State v. Tammy Caison Moorner with the Court of Appeals. On July 12, 2023, counsel filed the initial brief of appellant and designation of matter in The State v. Shakoya Darby with the Court of Appeals. On June 30, 2023, counsel filed the brief of appellant and designation of matter in The State v. Codrian Smalls with the Court of Appeals. On June 30, 2023, counsel, along with co-counsel, filed the brief of petitioner in William Bruce Justice v. The State with the Supreme Court. On June 22, 2023, counsel filed the petition for rehearing in The State v. Tammy Caison Moorner with the Court of Appeals. On June 8, 2023, counsel had an oral argument in The State v. Lutavious Elmore before the Court of Appeals. On May 30, 2023, counsel filed the petition for writ of certiorari to the Court of Appeals and accompanying appendix in Matthew C. Dwyer v. The State with the Supreme Court. On May 26, 2023, counsel filed the petition for writ of certiorari and accompanying appendix in Mary Nimmons Patrick v. The State with the Supreme Court.

4. Counsel makes this request in good faith and not for purpose of delay.


