**SCHEDULING ORDER**

This matter came before the Court on June 7, 2023, for a status conference. Present at the status conference were Kirby D. Shealy, III and David L. Brown for Pennsylvania National Mutual Casualty Insurance Company (“Penn National”) and W. Brad Nes, Jonathan M. Robinson, Tina Cundari, and Shanon N. Peake for Covil Corporation, by and through its duly appointed Receiver Peter D. Protopapas (“the Receiver”). Karen Yarrish and Boyd Wright, representatives from Penn National, and the Receiver were also present. Prior to the status conference, the Receiver and Penn National submitted reports to the Court regarding the status of Penn National’s digitization and production of microfiche cards as ordered by the Court on May 5, 2022.<sup>1</sup> The Court has reviewed the status reports and discussed this ongoing discovery matter with counsel. The Court hereby enters the following scheduling order:

1. Penn National shall complete the digitization of the microfiche cards and provide access to a searchable database containing all digitized material to the Receiver by July 31, 2023.

<sup>1</sup> Penn National appealed this order to the Court of Appeals and Supreme Court. However, the appeals were dismissed by the appellate courts as interlocutory, and the discovery matter has been remitted back to this Court.

2. This matter will be set for trial on September 11, 2023.
