1. The Initial Brief of Appellant and Designation of Matter in this case are due to be served and filed today.



Treatment of Antonio D. Patterson with this Court on July 19, 2023. Counsel filed the Initial Brief of Appellant in the case of The State v. Arkevus Jimon Cauthen with this Court on July 12, 2023. Along with Co-Counsel, Counsel filed the Petition for Rehearing in the death penalty case of Andres Antonio Torres v. The State with the Supreme Court on July 11, 2023. Counsel filed the Brief of Appellant, and Record on Appeal in the case of The State v. Shane Robert Clamp with this Court on July 5, 2023. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.


